EXPECT AN INCREASE IN CHILD ABUSE & NEGLECT

Previous natural disasters indicate that we can expect increases in child abuse and neglect and domestic violence.1

Nearly 75% of children involved in the foster care system are there because of fixable family issues.² Unemployment, inadequate housing, medical and food insecurity will contribute to more cases of neglect entering the State's foster care system.







EXPECT LONGER LENGTHS OF STAY FOR CHILDREN IN FOSTER CARE

The foster care system does not have capacity to properly care for more children. As more kids enter foster care, caseloads will increase, leading to case manager turnover and longer lengths of stay for kids in foster care.4
